
**Amendment No. 7 to Sewer Service Parcel Tax
Bylaw No. 8924**

The Municipal Council of the City of Kelowna, in open meeting assembled, enacts as follows:


1. THAT Sewer Service Parcel Tax Bylaw No. 8924 be amended by deleting section 2 in its entirety and replacing it with the following:
 - "2. The Parcel Tax shall be levied in each year on each parcel of land aforementioned, and the amount of such Parcel Tax shall be Zero Dollars (\$0.00).
2. This bylaw may be cited for all purposes as "Amendment No. 7 to Sewer Service Parcel Tax Bylaw No. 8924".
3. This bylaw will come into full force and be binding on all persons on adoption.

Amendment No. 29 to Sewerage System User Bylaw No. 3480

The Municipal Council of the City of Kelowna, in open meeting assembled, enacts as follows:

1. THAT Sewerage System User Bylaw No. 3480 be amended by:
 - (a) Deleting Section 4 in its entirety and replacing it with the following:
 - "4. Residential users shall pay a monthly flat rate charge for each residential unit for the use of the sewerage system as follows:


\$17.79 per month."

Amendment No. 30 to Sewerage System User Bylaw No. 3480

The Municipal Council of the City of Kelowna, in open meeting assembled, enacts as follows:


1. THAT Sewerage System User Bylaw No. 3480 be amended by deleting "0.78m³" in Section 5 (1) after the words "City of Kelowna Water Utility at the following rate for each one (1) cubic meter" and replacing it with "\$0.79/ m³";
2. AND THAT Sewerage System User Bylaw No. 3480 be further amended by deleting the words "Effective January 1, 2005, \$9.50." in Section 5(1) after the words "Provided that the monthly charge shall not be less than:" and replacing it with the words "Effective April 16, 2010 \$9.70".
3. This bylaw may be cited for all purposes as the "Amendment No. 30 to Sewerage System User Bylaw No. 3480".
4. This bylaw will come into full force and be binding on all persons on adoption.

Read a first, second and third time by the Municipal Council this 15th day of March, 2010.
