Notice of Local Area Service Completion – Southeast Kelowna Integration Project Benefitting Property

The City of Kelowna is pleased to advise property owners within the above Local Area Service that the project is complete.

Property owners are now being asked to choose one of the three payment options explained below and return the enclosed Declaration of Payment Option by **4:00 p.m. April 21, 2022**:

Option 1: One-time payment in the amount of \$6,530.23

Option 2: Defer the full cost as part of your 2022 Property Tax Deferment.

Option 3: Annual payments of approximately \$492.86 per year for each of the eighteen (18) years beginning in 2022. No action required if you choose option 3.

If you choose **Option 1**, payment must be received by **4:00 p.m. April 21, 2022**.

- Please make cheques payable to City of Kelowna.
- Post-dated cheques are accepted prior to the deadline.
- Full payment can be made through online banking using your Roll Number (shown above) as your account number.

If you choose **Option 2**, you must notify the Revenue Branch of your intent to defer by **4:00 p.m. April 21, 2022**. **IMPORTANT: Review the information on the provincial tax deferment website at gov.bc.ca/propertytaxdeferment to determine if you are eligible for the property tax deferment program.**

If no response is received by April 21, 2022, then the annual payment Option 3 will be applied to the property's 2022 taxation notice.

- Option 1:** One-time payment in the amount of **\$6,530.23**. The enclosed cheque made payable to City of Kelowna is dated no later than **April 21, 2022**.
- Option 2:** Defer the amount of **\$6,530.23** as part of my 2022 Property Tax Deferment. See NOTE below.
- Option 3:** Annual payments of approximately **\$492.86** per year for each of the eighteen (18) years beginning in 2022. **No action required if you choose Option 3.**

NOTE: If you are choosing to Defer, you are responsible for confirming your eligibility and submitting your property tax deferment application to the Province of BC. Applications are accepted online only at gov.bc.ca/propertytaxdeferment.

The annual payment Option 3, including penalties, will be applied if for any reason you:

- are found ineligible for the Property Tax Deferment program
- cancel or withdraw your application before the deferment office pays the charges on your behalf
- sell your home before the deferment office pays the charges on your behalf.
