### **Purpose**

A process to provide copies of City documents and plans from **the Building & Permitting branch** regarding a specific property or properties.

The City does not guarantee the availability of information for all files. The City endeavors to provide accurate information for the property file search in a timely manner and ensures the privacy of property owners is protected and copyright regulations are followed.

### Requirements

Provide a completed Property Information Request form (attached), to City Hall or email to <a href="mailto:developmentservicesinfo@kelowna.ca">developmentservicesinfo@kelowna.ca</a>

Owner's Authorization Form signed by the property owner(s). A City of Kelowna Owner's Authorization form or Real Estate Listing will be accepted alongside a Property Information Request form in lieu of obtaining the owner's signature. If the property is a strata, authorization from the Strata Council is also required.

#### Cost

The rate for a property information request is \$30 an hour. Standard requests will be billed for 1.5 hours, totaling \$47.25 with GST included. Any complex requests requiring additional time beyond the initial 1.5 hours will incur a further \$30 per hour fee which will be added once the file search is complete.

Fees are payable by cash, cheque, or debit in person, or by credit card online (you will receive an email with a link to pay). Upon receipt of payment, files are sent via One Drive.

In addition, homeowners requesting information prior to submission of a building permit can have the property information request fee applied as a credit towards their building permit fees, with proof of payment.

Requests for changes in zoning/land use, site development, and comfort letters must be requested separately through the appropriate department.

  - Secondary suites/ carriage houses
  - Single Family Dwelling/Survey
- Occupancy permits for:
  - Main building structure
  - Accessory structures
  - Secondary suite /carriage house
