

# Kelowna Water Smart City of Kelowna Water Utility



## Single Family Dwelling Irrigated Landscape Rebate Application

*The City of Kelowna Water Smart program through the City of Kelowna Water Utility is offering a rebate program for single family dwellings wanting to update irrigated landscaped areas of 100 square meters or larger. The deadline for completion will be discussed with a Water Smart representative.*

### **Rebate Value:**

The Irrigated Landscape Rebate will provide up to \$3,000 per residence towards a package that includes the following activities:

#### Design:

Where a designer is hired, up to 50 per cent of the cost of landscape or irrigation design services to a maximum of \$500.

#### Climate Appropriate Plants and sufficient growing medium:

Up to 50 per cent of the cost of climate appropriate plants

Up to 50 per cent of the cost of appropriate growing medium; depth and type as per BC Landscape and Nursery Association standards.

#### Mulch / soil amendments:

50 per cent of the cost to purchase *OgoGrow* or *GlenGrow*, or both, to a maximum of \$500.

#### Permeable landscape material:

Up to 50 per cent of the cost of permeable landscape material. Note that permeable landscape material cannot exceed 30 per cent of the total renovated area.

#### Irrigation Equipment:

Up to 50 per cent of the cost of irrigation equipment including but not limited to controller upgrade, master valve/flow sensor, pressure regulation, pressure compensating sprinklers, micro irrigation and related components required to operate equipment.

### **Application submission:**

- 1) Applications are to be completed in full and submitted to:

- 2) Applications will be accepted up to and including August 31, 2021.
- 3) Applications will be reviewed as they are received and for successful applicants, funding will be awarded on a first come, first served basis until such time as all available funds have been allocated.

## Eligibility

- Only residential properties connected to the City of Kelowna Water Utility system in **Southeast Kelowna area (former SEKID residents)** are eligible for this rebate. Properties served by private wells or utilities, improvement districts do not qualify as they are not supplied by the City of Kelowna Water Utility system.
- Applicants must own a property greater than 1 acre and only have access to the potable water system. Properties <1 acre are still eligible for a rebate up to \$1,000.
- Applicants must discuss project deadlines with a Water Smart representative.
- Applicants must specify that the proposed irrigated landscape changes will result in reduced irrigation water use of 20 per cent or more for the project area.
- The program applies for landscape upgrades only; previously un-landscaped areas do not qualify.
- The program is not retroactive. Sales receipts and/or contractor invoices are required for all rebates.
- Rebate cheques will be issued to the declared property owner, as indicated on the application.

## Irrigated Landscapes Rebate Program Process:

- 1) Submit the **Water Smart Landscapes Rebate Program application** for review.
- 2) Submit the Landscape Water Conservation Report ([kelowna.ca/watersmart](http://kelowna.ca/watersmart) > residential irrigation) for the area to be upgraded.
- 3) Schedule pre-construction site visit.  
If the application is approved, Kelowna Water Smart (Water Smart) will contact the applicant or their designated contractor to schedule a "pre-construction" site visit. At the site visit, Water Smart will review the area in to be renovated along with the upgrade plan as set out within the rebate application. Water Smart will take several "before" pictures of the area.
- 4) Complete the irrigated landscaped project.  
Upon completion of the pre-construction site visit and approval of the upgrade plan in principal, the applicant is notified and must complete the project prior to the project deadline.
- 5) Schedule a post-construction site visit.  
Once the project has been completed, the applicant will contact Water Smart to schedule a post construction site visit. At the post construction site visit, Water Smart will confirm that the project as described in the approved application, has occurred. Water Smart will collect receipts for products purchased and or invoice(s) from contractors secured to complete project work. Kelowna Water Smart will also take several "after" pictures of the project and may return during the next two subsequent seasons for additional pictures after additional grow in.
- 6) Rebate processing: Water Smart will have up to 30 days to review receipts and invoices and to issue a cheque to the applicant. If any pre-approved upgrades are not completed, the City of Kelowna reserves the right to withhold all or part of the rebate value for the project in question.

## Project Activities:

Project activities that would qualify for the rebate include, but are not limited to, the following:

- I. Replacing cool season turf grass areas with lower water use, climate appropriate, plant material.  
A good resource for climate appropriate plant choices is the Okanagan Xeriscape Association plant list. Appropriate depth of growing medium must be installed. Planted areas must be covered with a 3-inch layer of mulch.
- II. Replacing cool season turf grass areas with drought tolerant turf grass. Appropriate depth of growing medium must be installed.
